

# A WSBFA MASH-UP

We can work it out: The Beatles (1965)

After almost two years of negotiations, our Unit I members voted in June to approve a new Memorandum of Agreement, 167-23. Our *Chief Negotiator, President, Ernie Lewis*, wishes to extend his sincere appreciation to the entire negotiating team: *Executive Vice President, Devon Anderson, Secretary Treasurer, Nicholas Catti, and First Vice President, Holly Michels*. In addition to the Representative Assembly who approved the Memorandum of Agreement unanimously, Ernie wants to thank the 60% of our members who took the time, during an extremely hectic time of year, to attend one of our three ratification meetings and VOTE! We would be remiss if we did not commend the "other side at the table" for the feeling of mutual respect that they demonstrated during this very challenging economic climate.

#### Bridge Over Troubled Water: Simon and Garfunkle (1970)

Just a perfect way to explain the **Triborough Amendment** which was added to the Taylor Law in 1982. An easy way to explain it is to think of it as a bridge from one contract to another. It basically means that an expired contract actually remains in effect until a new one is negotiated and agreed upon. Unless otherwise noted, the only item that does not carry over is the "new money". Obviously, there is no salary increase until one has been negotiated. Step increases remain in effect until any modifications are agreed to in the new agreement. Members at the top step do not receive any raise until one is agreed to because they have no step above them. All you need to remember is that the *Triborough Amendment is critical to the health and well being of a fair negotiations process: It levels the playing field and encourages both sides to negotiate, while navigating through very Troubling Tax Cap Waters, in good faith.* In recognizing that labor peace serves the public good, the legislation prohibits public workers from striking while protecting their rights to bargain.

#### Working for a Livin': Huey Lewis and the News (1982)

The most critical challenge of negotiating in a BOCES is to focus on the fact that we are tuition-based. Rather than reaching out to the public for Budget Approval like each of our 18 component districts do, our Management Team has to establish a tuition rate that includes all essential expenses. The BOCES Budget is presented to the Districts for their approval annually. The rate has to remain competitive in order for our districts to continue sending students to our programs. In any language, this means that jobs can be at stake. The barometer that we use to measure success or failure is the amount of our members who get excessed each year. Incredibly, as *CEO Mike Flynn* said on opening day: "for the 16<sup>th</sup> consecutive year, we have not excessed one member - in fact 8 new teachers have been hired." According to Mike, while many school districts enrollments have been declining; ours has remained relatively stable. Unfortunately, there always seems to be one or two members who find themselves in jeopardy and the potential loss of even one person upsets us. However, due to the diversity of our programs, we are usually able to work with management to help create pieces of work to help any member who finds themselves in this position. Important: No one is excessed until the August Board Meeting. There are "excessing rights" that you need to be aware of and we will always be here to help.

During negotiations this year, one critical fact was made clear by administration: Western Suffolk BOCES began this year with a 9 million dollar deficit due to the current retiree health insurance cost.
